#### ADDITIONAL CARDLOCK TERMS OF USE

Any account that is 30 days past due may have its cards "invalidated" without notice. The cards will not be reinstated until the account is current or satisfactory arrangements have been made.

- 1. Purchaser shall be responsible for all purchases by Purchaser or any other person using Cardlock cards issued to Purchaser, regardless of whether use by any other person is unauthorized or fraudulent.
- 2. Purchaser represents that it and any person using the Cardlock cards delivered to Purchaser are and shall be aware of the proper use of the Cardlock system and shall use safe practices in compliance with the regulations of the local Fire Code in the handling of the fuels dispensed from the Cardlock system. Purchaser agrees to indemnify and hold Supplier harmless from any claims and costs including, but expressly not limited to, those for bodily injury and property damage which may be occasioned by the negligence or misuse of the Cardlock system by Purchaser or any person using the Cardlock system with Cardlock cards delivered to Purchaser hereunder.
- 3. Supplier shall use its best efforts to maintain the Cardlock system in good working order and condition at its expense. Supplier, however, shall not be responsible for any damage or loss that may result from its failure to provide fuel or from the failure of the Cardlock system in any manner whatsoever. Purchaser agrees that it and any person using the Cardlock cards delivered to Purchaser shall promptly notify Supplier of any malfunctioning of the Cardlock systems of which Purchaser or such person is aware.
- 4. Purchaser's right to purchase fuel throughout the Cardlock system may be terminated immediately upon breach of any of the terms hereof or of any other agreement with Supplier. Upon termination, Purchaser agrees to immediately surrender all Cardlock cards issued to Purchaser and to immediately pay all outstanding sums owing to Supplier.
